

There are several different types of legacies and choosing how to make your gift is an important decision.

The types of legacy are:-

# 1. Residuary Legacy

This is a gift of the remainder or percentage of your estate after all other legacies have been made and debt cleared. Residuary legacies keep up with inflation and are an effective way to divide the value of an estate between a number of people and causes that important to you. If you are considering what type of legacy to leave Citizens Advice Ipswich, a residuary legacy can help your gift go further.

# Residuary Bequest (a proportion of your estate) wording

I give (..&) of the residue of my real and personal estate which I can dispose of by Will in any manner I think proper to Citizens Advice Ipswich (registered Charity no. 1064862) of 19 Tower Street, Ipswich, Suffolk, IP1 3BE and the receipt of the Honorary Treasurer or the proper officer for the time being of Ipswich and District Citizens Advice Bureau shall be a complete discharge to my executors.

## 2. **Pecuniary Legacy**

This is gift of a fixed sum of money. The value of pecuniary legacies will decrease over time, as the cost of living increase.

### Pecuniary Bequest (a set sum) - wording

I give the sum of ....... pounds to Ipswich and District Citizens Advice Bureau (Registered charity 1064862) of 19 Tower Street, Ipswich, Suffolk, Ip1 3BE and the receipt of the Honorary Treasurer or the proper officer for the time being of Ipswich and District Citizens Advice Bureau shall be a complete discharge to my executors.

### 3. Specific Legacy

A particular item left as a gift in your Will is known as a specific legacy, for example, a piece of land, property or artwork.

### Specific Legacy Bequest (a maned item) – wording

I give Ipswich and District Citizens Advice Bureau (Registered charity 1064862) of 19 Tower Street, Ipswich, Suffolk, IP1 3BE, absolutely, may (name of property, shares, land or description of item).

#### 4. Life interest or Reversionary Legacy

This is a gift which someone can benefit from in their lifetime. For instance, your house, your house could be left for the use of a relative. When they die it could pass to someone else, or on to Citizens Advice Ipswich.

## Reversionary legacies / Life interest trusts – wording

My trustees shall hold [...] on trust for [...] during his lifetime and, following his death hold the capital and income for Ipswich and District Citizens Advice Bureau (registered charity1064862) of 19 Tower Street, Ipswich, Suffolk, IP1 3BE, and the receipt of the Honorary treasurer or the proper officer for the time being of Ipswich and District Citizens Advice Bureau shall be a complete discharge to my trustees.

## 5. Contingent Gifts

Legacies made on a basis of another event happening first are called contingent gifts. For example your Will could state that a gift only applies if all beneficiaries named in your Will die before you do.

# Get the wording right -

If you have decided to remember Ipswich and District Citizens Advice Bureau in your Will we recommend taking this wording to your solicitor. Firstly, it is important that the following clause is included in your Will:

"If at my death any charity named as a beneficiary in this Will or any Codicil hereto has changed its name or amalgamated with or transferred its assets to another body then my executors shall give effect to any gift made to such charity as if it had been made (in the first case) to the body in its changed name or (in the second place) to the body which results from such amalgamation or to which such transfer has been made" Please remember to use our full name Ipswich and District Citizens Advice Bureau and our charity number 1064862 and registered charity address: 19 Tower Street, Ipswich, Suffolk, IP1 3BE
